# THE LICENSING ACT 2003 HEARING REGULATIONS 2005

#### SUB-COMMITTEE PROTOCOL

#### **PROTOCOL**

#### 1. The Notice of Meeting

- (a) The Notice of Sub-Committee meeting issued by the Council shall be accompanied by the following:
  - (i) A report of the Licensing Officer which shall include:
    - (a) Conditions the Licensing Officer considers relevant in the event that the application is granted;
    - (b) Any matters which in his opinion require clarification; and
    - (c) Observations on the application in relation to the Licensing Objectives, National Guidance and local policy.
  - (ii) Where relevant, the notices which have been given by the applicant and other parties under the Act.
- (b) The Notice of Meeting shall be served upon:
  - (i) The applicant (together with copies of relevant representations under the Act);
  - (ii) Persons who have made relevant representations under the Act; and
  - (iii) Where appropriate the Chief Officer of Police who has given notice under the Act.

#### 2. Appearances and Submissions

#### (a) Constitution of the Sub Committee

A Member of a Ward in which the premises are located and is the subject of an application shall not be a Member of the Sub-Committee determining such application.

#### (b) Parties entitled to appear

In accordance with the Licensing Act 2003 (Hearings) Regulations 2005 any person making relevant representations, the applicant and the Licensing Officer may attend the hearing and may be assisted or represented by any person whether or not the person is legally qualified.

#### (c) At the Hearing

Any party shall be entitled to:

- (i) Respond to any point in support of their application or representation which the Licensing Authority (the 'Authority') has given notice that it may require further clarification on;
- (ii) Normally to put questions to any other party; and
- (iii) Address the Sub-Committee.

### (d) Consequences of non-attendance

- (i) The Sub-Committee will normally proceed with a hearing where a party has informed the Authority that it does not intend to attend or be represented at the hearing.
- (ii) Where a party has not so indicated but fails to attend or to be represented at the hearing the Sub-Committee may, at its discretion, where it is considered necessary in the public interest, adjourn the hearing to a later date or hold the hearing in the party's absence subject to, (in the latter case), the Sub-Committee considering the application or representations made by the absent party.

#### (e) Submissions to the Sub Committee

- (i) Subject to each party being given an equal maximum time the Sub-Committee may, at its discretion, where it considers appropriate in the public interest, advise parties that it will impose a time limit on speeches or submissions to be made to it.
- (ii) The Sub-Committee may, at its discretion, request that where a number of relevant representations repeat or in substance repeat a representation, that a representative of those making such representations make submissions to it on behalf of the other parties.
- (iii) The production of draft conditions by the Licensing Officer shall not be construed as influencing the Sub-Committee in advance of hearing representations and are produced for administrative convenience in the event that, following formal determination of the application, the Sub-Committee considers it appropriate to grant consent but with such conditions as it may consider appropriate.
- (iv) The Sub-Committee shall not have regard to any information first produced by a party at the hearing without first obtaining the consent of other parties present at the hearing.

#### (f) Conduct at the Hearing

(i) The Sub-Committee may, at its discretion, require a person to leave the hearing and refuse to permit that person to return or to return only on such conditions as the Sub-Committee specifies if, in its opinion, that person is behaving in a disruptive manner, provided that such person may submit written evidence in accordance with the Regulations.

- (ii) Any irregularity arising from any failure to accord with this procedure shall not make the hearing void. If any person has clearly been prejudiced the Authority will take appropriate steps to rectify the irregularity before reaching its determination. Clerical mistakes in a document arising from accidental slip or omission may be corrected by the Authority.
- (iii) The public (including any parties or their representatives) may be excluded from part of the hearing where the public interest in so doing outweighs the public interest in the hearing taking place in public.
- (iv) The Sub-Committee may adjourn the hearing to a specified date where it considers it necessary to obtain further information or to facilitate representations or to assess such representation at or in the vicinity of the premises.

### 1. **RECOMMENDATIONS**

- 1.1 That the Sub-Committee consider and determine an application made by Little Monster Brewing Company Limited for a Premises Licence variation.
- 1.2 If the determination is to grant a varied Premises Licence, to give consideration as to whether it is appropriate to attach conditions to ensure the statutory licensing objectives are promoted.
- 1.3 The Sub-Committee is to give reasons for its decision.

## 2. REASONS FOR HEARING

2.1 The application to vary the existing Premises Licence submitted by Little Monster Brewing Company Limited of Metherell Gard, Burn View, Bude, Cornwall, EX23 8BX (Company Number 11228185) has attracted 32 relevant representations. Of the representations, 21 are in support and 11 in opposition to the application. No representations were received from any of the designated Responsible Authorities under the Licensing Act 2003. All the representations were made by members of the public.

# 3. BACKGROUND

Included in this report are the following attachments:

- 3.5 Copy of the existing Premises Licence (and conditions) for Little Monster Tap. (Premises Licence number 3815/23/00770/LAPRED) (Attachment D).

#### 4 SUMMARY OF THE PREMISES LICENCE APPLICATION

- 4.1 A copy of the application to vary the existing Premises Licence is reproduced in full at Attachment B.
- 4.2 Little Monster Brewing Company Limited submitted a valid application on 14 July 2023. As part of the application process, statutory public notices were displayed by the applicant at the premises during the representation period which ran between 14 July 2023 and 11 August 2023 inclusive. In addition, a copy of the statutory public notice was published in the Chichester Observer series on 20 July 2023.
- 4.3 Below are extracts taken from the application form in which the applicant provided a general description of the site and nature of the variation being sought:

The current licence allows the sale of alcohol from 12.00 – 21.30 hours and we wish to extend this from 12.00 to 23.00 hours. **An additional 1.5 hours.** 

The current licence allows the opening of the premises from 12.00 to 22.00 hours, and we wish to extend this from 12.00 to 23.30 hours. **An additional 1.5 hours.** 

We will only open until these times subject to planning.

The applicant has also identified a condition currently imposed on the licence which they believe could be removed as part of the variation application, this is Condition 7 of Annex 2) of the current Premises Licence which states:

"No tapped lagers, or spirits, will be sold for either on or off sales".

In support of the application a new plan was also provided illustrating a rotation of the bar (by 90 degrees) making it, in the applicants' experience "easier to view customers coming into and exiting the premises to better adhere to the four licensing objectives".

- 4.4 The variation application therefore seeks to extend the existing hours the premises is authorised to undertake the supply of alcohol by 1.5 hours with the terminal hour being 23.00 hours rather than the current 21.30 hours.
- 4.5 Naturally the hours the premises would be open to the public would also need to be extended if the application is successful. The current terminal opening hour is 22.00 hours and thus would be extended to 23.30 hours incorporating an additional 1.5 hours.
- 4.6 The table below sets out the existing opening hours and activities on the current Premises Licence compared to what is being applied for.

Licensable Activity	Current hours on existing Premises Licence	Proposed hours as part of variation application
Supply of Alcohol (Consumption indoors & on the premises only)	Everyday 12:00 to <b>21.30</b>	Everyday 12:00 to <b>23.00</b>
Hours premises are open to the public	Everyday 12:00 to <b>22.00</b>	Everyday 12.00 to <b>23.30</b>

- 4.7 Due to statutory deregulation that has come into effect since the Licensing Act 2003 was introduced in 2005, it is important to be aware that with respect specifically to live music and recorded music, these activities are not actually licensable if all of the following criteria is met:
  - The live or recorded music takes place between 08:00 and 23:00.
  - It takes place at an alcohol on-licensed premises; and
  - The audience is no more than 500 people.
- 4.8 Given the capacity of the licensed premises is under 500 and it already has an alcohol on-license should live or recorded music take place at the premises between 08.00 and 23.00 these would not be licensable activities.
- 4.9 The applicant provided additional information in their Operating Schedule as to how they intend to take to promote all four of the licensing objectives should the variation be granted. This is shown within the application form at Attachment B.

## 5 THE PROCESS AND PROMOTION OF LICENSING OBJECTIVES

- 5.1 The legislation provides a clear focus on the promotion of four licensing objectives which must be addressed when licensing functions are undertaken. Each objective is of equal importance. The licensing objectives are:
  - The prevention of crime and disorder,
  - Public safety,
  - The prevention of public nuisance, and
  - The protection of children from harm.
- 5.2 In carrying out its licensing functions, the Licensing Authority must also have regard to its current Statement of Licensing Policy 2022-2027, statutory guidance published by the Home Office (August 2023) along with relevant matters raised in any representation(s).

## 6 RELEVANT REPRESENTATION(S)

- 6.1 A representation is "relevant" if it relates to the likely effect of the grant or variation of a licence on the promotion of at least one or more of the licensing objectives. Representations can be in opposition or support of an application. As stated at paragraph 2.1 above, this application attracted 32 relevant representations, 21 of which are in support and the remaining 11 in opposition. All relevant representations that subsist are reproduced in full at Attachment C.
- 6.2 It is for the Licensing Authority to determine whether a representation (other than a representation from a Responsible Authority of which there are none for this particular application) is frivolous or vexatious. A representation may be considered to be vexatious if it appears to be intended to cause aggravation or annoyance, or without reasonable cause or justification. However, it is recommended that, in borderline cases, the benefit of doubt about any aspect of a representation should be given to the person making the representation.
- 6.3 Amongst other things the supporting representations comment positively on the ambience of the premises and its welcoming nature, reflected in the clientele it attracts. There were supportive comments about the responsible management ethos at the venue. Comments are made based on customers and some neighbours own experiences, most notably the lack of evidence or incident at the premises that undermine any of the four licensing objectives and that extending the operating hours at the premises would not change this. Reference is also made to its city centre location, other licensed premises in the area and a shared desire to support small independent businesses that act as a community hub.
- 6.4 The representations in opposition refer to a number of matters, it is evident that the main areas of concern particularly relate to the likely effect on the promotion of the Public Nuisance and Prevention of Crime and Disorder objectives should the extension to hours be granted as a result of the variation application. Such matters raised include encouragement of more drinking, concerns around increased noise, loud music, littering and urination. One representor suggests the application will have a "wholly detrimental impact on the lives of people living nearby" with another stating the application site is "unsuitable for extended use being in the middle of a residential area".

## **7 CONSIDERATIONS**

- 7.1 In reaching its determination, the Sub-Committee must take into consideration the promotion of the four statutory licensing objectives, the Council's Statement of Licensing Policy, the current Home Office Guidance along with written and/or oral evidence during the hearing.
- 7.2 It is very important to note that these are the only matters to be addressed by the Licensing Authority when considering this application. The licensing objectives are the only grounds on which representations can be made, and the only grounds on which the Licensing Authority will be able to refuse an application or impose appropriate conditions in addition to mandatory conditions and those proposed by the applicant in their operating schedule.
- 7.3 Human Rights considerations must be taken into account fully in balancing licensing issues, in particular, article 1 of the first protocol and articles 6 and 8. Article 1

relates to the protection of property and the peaceful enjoyment of possessions and property (holding a licence would be considered a possession). Article 8 relates to the right to respect for private and family life, home and correspondence. Article 6 relates to the right to a fair trial. These are however qualified rights and can be deprived of "in the public interest". Interference is permissible if what is done: -

- Has its basis in law:
- Is necessary in a democratic society to fulfil a pressing need or pursue a legitimate aim,
- Is proportionate to the aims being pursued; and,
- Is related to the prevention of crime or, the protection of public order or health or the protection of the rights and freedoms of others.
- 7.4 The Sub-Committee must consider each application on its own merits, and in accordance with the principles of natural justice, as well as the provisions of the Licensing Act 2003. All relevant factors must be taken into account, and all irrelevant factors must be disregarded.
- 7.5 All applications before the Sub-Committee must be considered against the backdrop of anti-discriminatory legislation including the Equality Act 2010 and in accordance with the Council's current Equality Strategy.
- 7.6 In accordance with Section 17 of the Crime and Disorder Act 1998 the Council is under a duty to exercise its functions with due regard to the likely effect on, and the need to do all it reasonably can to prevent, crime and disorder in its areas. The possible crime and disorder implications are clearly relevant factors in the consideration of all applications and this is re-emphasised by the Licensing Act 2003 itself. In giving "due regard" to these possible implications members will consider and weigh up all the information available and representations made, including those from Responsible Authorities and any other person(s).
- 7.7 The Sub-Committee are required to give reasons for their decision.

### 8. OPTIONS OPEN TO THE SUB-COMMITTEE

- 8.1 When considering this application, the following options are available to the Sub-Committee:
  - (a) Grant the Premises Licence variation, as applied for;
  - (b) Grant the Premises Licence variation as applied for along with any additional conditions considered appropriate to promote one or more of the licensing objectives on which relevant representations have been received.
  - (c) Reject the whole or part of the Premises Licence variation application.



#### a) General – all four licensing objectives (b, c, d, e) (please read guidance note 11)

The product to be offered at the micro pub are quality generally small batch, meaning that customers appreciate them rather than consuming volume irresponsibly. Volume and binge drinking is not encouraged. Volume discounts will not typically be forthcoming. Prices of our alcohol drinks will discourage that behaviour. Our knowledge of real ale and brewing will be on hand to educate customers about our beers.

As the micropub is by its nature is small, we will be able to closely observe customers behaviours and well being. Experience has shown that micro pub owners soon build relationships with their clientele and they accept the behaviours expected of them with respect to the business and it's place in the community.

We have rotated the position of the bar by 90 degrees as this provides better viewing of the premises and customers coming in and exiting.

## b) The prevention of crime and disorder

The bar manager who holds a personal licence will be staffing many of the sessions and overseeing the safe and compliant operation of the micropub. He will ensure the licencing law is upheld., Staff will be inducted to adhere to this.

The entrance will be well lit whilst window lighting will be subdued to give good views of thos entering and those passing on the payment respectively.

Cash handling will be discreet and kept out of sight where possible.

Drunkenness and anti social behaviour will not be tolerated with robust action taken against offenders. A ZERO tolerance policy will be taken on drug use, violence and disorderly conduct. We have 6 cameras installed within the premises which acts as a deterrent and also records all activity.

#### c) Public safety

The micropub layout is straightforward in that the entrance/ exit at the front is in the centre and the fit out design keeps this access clear sufficiently for wheelchair users. This area will also be well lit and signed. The staff will have good sight of the front door and also the pavement outside. Customer numbers can affectively be monitored as the capacity will comprise of a specific amount of seated customers with the remainder standing up to the limit of 56.

The staff can advise on safe passage home. Taxi numbers, bus times and routes and rail timetables and train status will be on hand and available.

#### d) The prevention of public nuisance

Public nuisance factors are very low here. There is no access/ exit to the rear, so the pavement to the front is the only route to and from the micropub. The size and ambience means that its straightforward for the owner and staff to monitor customers and to ensure they depart quietly and safely with respect to neighbouring business and residents. There are 3 opening sash windows on the first level. One is in the 'staff only' locked kitchen and the others are in the customer area—however these have a stop lock to prevent them opening past a safe height. As above, comprehensive information on taxis and public transport facilities are provided to enable customers to depart safely.

Additional cigarette disposal boxes will be installed outside the premises, although our new clientele are mostly vapers as opposed to smokers.

The tap room currently only has 1 toilet, similar to other drinking establishments in Chichester. However the extended hours will not put any additional pressure on the toilet facilities – this would only happen if we increased the number of people using the tap room. In any case, we will direct our clientele to the free facilities at Cattle Market car park.

#### e) The protection of children from harm





If not your Dept, please pass to <u>Licensing</u>, thank you.

My house is 2 doors from The Alehouse. I bought it 27 years ago when the Alehouse was a grocery store. There are flats above The Alehouse and to the west along The Hornet. My house is part of the Bishops Courtyard residential development, built 1994/6; 15 homes in total. After around 6pm the area reverts to being wholly residential. We don't support, or feel there is any justification for, an extension of hours as this will increase the noise, loud music, dirt, urine and faeces currently affecting our house, others in the Courtyard and the Courtyard itself, courtesy of The Alehouse's existence. A proper pub exists 60 yards down the road adjoining Eastgate Square. Historically the Alehouse premises have been used as a grocery store. The Alehouse calls itself a microbrewery, which could be considered unsafe in a residential area, a fire hazard and pollutant.

The only access The Alehouse has to the rear of its premises for disposing of waste is directly into the Courtyard. They have rights of access for storage of waste only over a narrow sliver of land on which they, the Carpet shop, and the 3 flats above keep their bins. They're not allowed to take vehicles into the Courtyard. Their rubbish bins have to be wheeled outside the gates for collection.

As things stand, The Alehouse is open to the public until 2200 hrs (closes for serving drinks 2130). The noise from putting out empty beer casks and other detritus from the day's business there impacts directly on Courtyard residents plus residents of the flats above. It's a noisy, anti-social business for a lot of people.

I object to the proposed extension of opening hours from 2200 hrs to 2330 hrs. This would have a wholly detrimental impact on the lives of people living nearby, including

rubbish being put in bins at midnight instead of 2230hrs, unruly behaviour of many of the pub's customers, peeing and defecating irresponsibly, and leaving litter, so much later than at present. Their mess is left for residents to clear up - 7 days and nights weekly. It is very unpleasant. I object also to the extension of closing time for the sale of alcohol from 2130 hrs to 2200 hrs.

I also object to the provision of music any later than 2130 hrs, the present closing time. How are people meant to sleep.

I object to the proposed removal of the limitation on the sale of tapped lagers and spirits. The Alehouse had limits applied to its sale of alcoholic products for good reasons and nothing has changed.

The Alehouse has 1 loo only, insufficient for the present number of customers who simply use Bishops Courtyard's walls, open spaces and the privacy this offers, instead. In summary, I object to an extension of serving and closing times; to an extension of product sales as mentioned, and to extending hours in which music can be played. The Alehouse abuts a busy pavement, immediately adjacent to an, at times, busy road. Safety can be an issue, as it is, and the licensing authority may wish to consider this matter too. Local residents, including families with young children, have had enough of the noise, dirt and rowdy behaviour that The Alehouse's customers create. A pub's a pub.

We have been advised that the above application has now been resubmitted following the failure of the original application . Our letter letter of the 20th June which I wrote to the Licensing Committee seems now invalid so we have revised have it as dated 14t July 2023.

We believe that the four licensing objectives (Public safety, prevention of crime and disorder, prevention of public nuisance and the protection of children from harm) will not be met with the revised hours.

The issue of extended hours is not just a matter for the Licensing Department and it should involve The Planning Department, The Environmental Health Department, Fire , Police and We believe, a letter to all owners of the Properties that make up Bishops Courtyard. Your Licensing requirement states that an Advertisement should be placed in a Local Newspaper which We do not believe is sufficient in this day and age especially as many of the properties are owned by Landlords who live away from Chichester. Your Officers correctly advise that the Applicant has a duty to inform via the press and by way of a circular/letter to local residents, if Local Newspaper circulation is considered sparse. Already , with this re-submitted application, We have looked for the mandatory notice in the Window of the establishment and it is not published at the time of writing.

We have wished the new management every success in their venture but in making this revised application we feel that it will have the potential to detract and encroach on our lives.

My wife and I are experienced property developers and fully researched our surroundings when we bought our property two years ago. We knew we were buying a property in a Commercial Street and were aware of The Eastgate Public House , its full license and its music noise as we were aware of the various take away establishments on The Hornet. We were also delighted to see The Hornet Alehouse two doors away with its specific license and its hours and its specific Ale trade. Its Clients smokers, drinkers , young and old seemed to be a good crowd and in the main remain so.

The change in ownership has shown a significant shift in the business model and the demographic has changed. It is a lot busier and we are pleased for them but we have seen the level of noise, cigarette butts and general congregation of vapers, smokers and general bon homie outside of the premises and the entrance to our courtyard increase in the last few months.

My Wife, Myself and one of our neighbours recently formed a team and entered The quiz night at the bar and we thoroughly enjoyed ourselves We think their may have been fifty or so people attending and the toilet queue was four deep at times and clearly there is a need for better facilities.

The management suggest that they may have a long term renovation scheme for the whole property which may include an additional toilet upstairs but The Chichester District Council has adopted The Local Government (Miscellaneous Provisions) Act 1976 Section 20.

This Act sets out the minimum requirements establishments with 1-25 covers need one WC with wash hand basin and an accessible version (Unisex) which might not meet their current disabled requirement presently in the establishment as there is no turning circle within the toilet area for a wheelchair. Numbers of 26-60 which is the probable capacity of the bar and upstairs requires the establishment to have one WC and hand basin for males and one WC and Hand basin for females it also seems to imply a third Accessible Unisex Toilet.

The Councils preamble mentions a higher standard may be required for what are referred to as businesses focusing on vertical drinking which one might consider The Alehouse to be.

My own experience when needing a toilet and finding it busy with a queue has been to go to my own home and come back. The experience of some who do not own a home in the proximity is to enter through our gates and urinate against the wall and dustbin area. Somebody in the courtyard now has to hose the area on a regular basis.

The fitting of locked gates to both pedestrian gates would cause a potential fire and safety issue were there a fire or serious accident outside the establishment as the Alehouse premises has only one fire escape in addition to the front door. This fire escape exits into Bishops Courtyard and thus the customers would be unable to escape the area as they would not have the key codes to leave the area.

The increased hours that are asked for will only add further incidents as the bar may become a hub for the last drink before the wait for the kebab, or takeaway. If the license is granted there is potential for increased noise from 9pm through to 11.30. On busy days the customer base expands along the pavement and into the entrance to Bishops Courtyard. We have experienced foul language only once but the sound permeates through and up into the Courtyard. The extended hours has the potential to exacerbate the situation. On these hotter days recently The door to the establishment is left open.

Under the current hours we have no complaints as the establishment is closed by 9.30pm so we have no reason to complain, other than the urination and smoking detritus. The urination is obviously caused by senseless individuals but their situation is not made easy due to the lack of toilets.

The original Planning Consent Decision Sign of Sheet 2434978 dated 4th January 2018 gave change of use to the site and the document brings up a number of issues including a point made by the Environmental Health Officer. They did not object to the proposal on the understanding that there would be no amplified music, live entertainment, tannoy, television or similar on the premises. All of the forgoing have been seen at the premises. Their reason-To protect the amenity of neighbouring residential dwellings

The document refers to the smoking issue and they concur with my previous concerns that this could generate undue noise and unduly harm the character of the street. Signage requiring patrons to remain in one area , sensitively designed and secure recepticals that could be brought in after closing limit vandalism that may be harmful to the amenity.

Due to the size of the building, and the relatively early closing hours proposed, it is not considered that the proposal would be likely to lead to large groups in the street, and any disturbance would be in the public realm and thus the jurisdiction of The Police. They made no mention of the toileting facilities at the time which should We believe have been a red flag based on The Council Guidelines.

The cigarette issue is really outside of the scope of the establishments control other than the vandalised cigarette receptical bolted to the wall frequently vandalised presumably to collect the butts for recycling. We know they can do little about the problem other than clear it up in the morning.

With regard to the bins, The Alehouse has the use of the courtyard for their refuse bins and in general they are not a problem. The increased trading hours will generate more waste and whist presently the bins seem to be accessed the next day it is possible that these increased hours may require the management to dispose of bottles cans and ancillary rubbish during trading hours which will affect us late at night. The establishment does not serve food other than snacks but they actively encourage their clientele to purchase food from any of the takeaway establishments in the town and consume it on the premises and this will add to further rubbish disposal problems. Twice a month they are visited by a street food operator who sets up and cooks outside the establishment.

The management will not want to store food waste on the premises overnight and may resort to binning this waste at the end of the shift. Not a problem at 9.30 -10pm but at 11.30 obviously an issue to The Residents of Bishops Courtyard.

In reading the many letters of support, comments and objections applying to the original application We note that a CAMRA representative wrote in favour of the application at the time.

"Micropubs represent both a revival of the simple origins of pubs, they sell local products, consisting of real ales, ciders, cold snacks, the small size of the premises, mean that the Landlord is in full control of what happens on their premises and the customers are well behaved, everything you do or say in a micro pub is likely to be seen and heard by the staff. People enter and leave in a respectful manner and the premises observes traditional or shorter opening hours which do not impinge on the neighbours."

The Alehouse, as it was, embodied all of the above but in its new format it has become a trendy lovely establishment and We believe it to remain a useful asset under its current hours and remit.

The Landlord and his staff are extremely pleasant but there are times when the establishment is Managed without the landlord being present and We believe that the extended hours may make the departing staff vulnerable there is rarely more than one in attendance.

There are many documents on line which relate to the original planning and license applications too numerous to mention individually but We would ask you to refer to them before making your decision to grant these extended hours.

We may not like the noise, the loud Sunday Music, the cigarettes and the low burble of conversation from those outside having a drink and a smoke, it is what We know and tolerated but the Owner is now looking to expand and it is this which we disagree with hence our objections. in researching for our Objection it would seem that The concerns or The Environmental Officer have been long ignored.

On looking at the current Licensing Application I note that there is a plan included which shows a red border around the two floors of the property, The Document states that Alcohol Consumption permitted only in the red borderline. The seating plan does not include the six additional poser tables and chairs nor does it include the two maybe three barstools. The bench seating is capable of seating perhaps 8 plus the additional six new seats and the window seats six people thus the seating capacity of downstairs is at least 30 with upstairs being 22 so a total seating of perhaps 50 and then some standing perhaps the potential of 60 customers. From the plan it would seem that no alcohol is consumed outside but I would ask you to draw your own conclusions here as it plainly is.

Finally the fact that a full hours License may be granted will reduce the value/saleability of our properties. From my own recent personal experience a bridging mortgage was refused on our property because of the proximity of a Licensed property. The Mortgage Supplier considered a busy pub down values residential property. It was only after an explanation that the Hornet Alehouse was only licensed until 9pm that the application was re-considered.

In summary we do not think the property is suitable for a full hours license in either its structure or its location. The Hornet has become a unique street in Chichester with traditional and bespoke businesses. There are more than enough fully licensed premises in South Street and The Eastgate is just along the road. Is it really necessary to have another late night drinking establishment.

We think there are environmental issues with regard to Noise through Live Music and crowded pavements in a busy and fast road.

There are issues for the Police with regard to The Street Congregation, Parking Issues for deliveries which will be greater.

There are Health and safety issues regarding vermin and food waste disposal.

Fire safety Risk and exiting issues from the establishment in case of fire.

Please also take into account our original letter 20th June and prior and subsequent email conversations as evidential to our Objections.

I will be returning to Chichester at the end of the month and will galvanise the absentee Landlords and their tenants to making the own comments regarding this application.

as a result has all of the problems that that can bring. Purchasing a property, a home, is usually the largest investment one makes in a lifetime and its an investment we would all wish to protect. The Monster Tap Room clearly has some passionate customers judging by the letters of support that have been published but at the end of an evening they all return to their homes. Would they feel differently if a fully licensed premises suddenly appeared next to their properties? The inadequate toilet facilities of the establishment have only become apparent in recent times since the Monster Tap Room changed hands from the Hornet Alehouse. Obviously we have no way of confirming where the perpetrators who choose to use our courtyard to urinate in have come from but it is a problem that has never occurred in the past. Last weekend I attended a meeting that the applicant and manager kindly arranged in order to inform us of their plans for the future. They assured me that they would be diligent in clearing the cigarette butts which are to be found in front of our courtyard gates and that they would ensure that rubbish would not be emptied into their bins, which are sited within our courtyard, at the end of the night. Whilst they are both amenable to the problems we are highlighting once a license is granted the next incumbents may not have their high standards. The applicant suggested that without the extended license he would have to close the business. I would suggest that Pade hsapplicant needed the extended

hours to make his business viable I would have thought it his responsibility to ensure that the property he was choosing was in a suitable area where a full license was acceptable. Not inflict it on residents above and around who were here before him. The Monster Tap Room and previously The Hornet Ale House clearly fulfils a need for many people. It employs local people, supports local charities. In its current format it clearly has a place in the city but as another objector has said it is perhaps trying to expand in a premises that is not suitable for their ambitious plans. I appreciate that Chichester needs to encourage independent business's into the City and we don't need anymore empty premises but that does not mean that CDC should have the power to change any retail unit into a fully licensed premises without regard for the people who are already living there and disregard its own guidelines. In 2017/18 23 The Hornet changed from a retail unit to a drinking establishment and the environmental health officer when considering the application clearly says that the premises is not suitable for; Live music, amplification, Tanoy, television or similar and his reasoning was in order to protect the neighbouring residential dwellings. Chichester District council has adopted the local government (miscellaneous provisions) Act which sets out the requirement for toilets for such establishments. Are these factors now going to be ignored?

Havingseen the application and associated objections, I write in support of the proposals to extend the opening hours of the Little Monster Tap (LMT). In the current climate, it would appear to me to be imperative to give local independent businesses the best chance of generating a profit to help them continue to thrive. The LMT offers a community environment that serves a product produced within the Chichester District as well as employing residents of the area and offering opportunities to local musicians.

Having considered the objections raised thus far, they would appear to somewhat fanciful, if taken at their highest. Notwithstanding the fact that one statement likely amounts to an actionable defamation against myself and other regulars.

The example of the queue for the bathroom facilities on a quiz night would appear to have been offered as a deliberately disingenuous example as to the generality of the situation. The quiz is run once a month and the format allows time for several breaks. Naturally, at these times people make use of the opportunity to use the bathroom and it may become busier than usual. However, being a micropub (not a microbrewery as erroneously stated in one objection) the limited capacity means that thefacilities on offer are easily adequate and the use thereof unlikely to require more than a momentary wait.

Since the inception of the building becoming a pub in the guise of The Hornet Alehouse, and continuing under the LMT, the venue has had a focus on offering a positive contribution to the local area and providing a safe and friendly atmosphere for all. In the five years or so that the premises has been open as a pub, I have personally never experienced any unruly or offensive behaviour either inside or outside the venue and have certainly not been aware of any customers engaging in behaviour that would amount to an

offence under the Public Order Act 1986. With The Hornet being the main thoroughfare back to the east of the city from the city centre, as well as it being proximate to many other public houses and takeaways, that any allegations of poor behaviour can be accurately attributed to anyone who has visited the LMT is entirely spurious and ill conceived. Given that I frequently pass by the gates of the Courtyard at various times of day due to the location of my own property, I am sure that I would have noticed the behaviour complained of. I have also never noticed being able to hear audible music from this point on The Hornet. Further, both the interior and the exterior curtilage appearance of the building have always presented as clean and tidy. Any customers either smoking or vaping outside the premises are always at pains to allow safe entry and exit to the building for others as well as ensuring that the passage ofother pedestrians is not impeded.

The fact that there is a pedestrian gate that cannot be locked due to the fact that it would impede the safe escape from the rear of the adjacent commercial properties can only to be seen to be due to the dereliction of the developer and/or freeholder or management company of the development. It would appear inequitable to seek to criticise the current occupiers of the commercial premises for the failures of those who constructed the domestic properties and neglected to put in place adequate mitigation for the storage of the bins of the existing premises and their fire safety requirements. If motivated to improve the situation, I'm sure the residents of the domestic properties could petition the current freeholder/management company to find a satisfactory solution.

Having considered the four planning objectives, it is difficult to see how the extension of the license for and additional 90 minutes would negatively impact upon these. The demographic of micropubs is naturally inclined to individuals who prioritise quality over quantity and against those who wish to drink with a view to getting drunk and becoming more likely to engage in crime, disorder, or public nuisance as a result. The LMT has always felt a safe environment to spend time in and is well served with CCVT cameras both internally and externally. Being a 'wet' pub, the premises does not tend to attract those who have children with them in this day and age. I am also aware that a Challenge 25 policy is in existence to prevent the service of alcohol to anyone who is under the age of 18.

However, having read some of the other correspondence you have received, I want to challenge some of the grounds of the objections made, because most are "imaginative" at best, and as a patron of the Taproom, downright insulting at worst.

- Calling the location a quiet residential area is laughable when almost the entire street is commercial property, including a wine warehouse, a motorcycle dealership and of course, another public house.
- Directly opposite the entrance to Bishops Courtyard is a Chinese takeaway open until 10:30pm on weekends, and a pizza takeaway open until midnight every night of the week. I'd suggest there is far more public nuisance to residents and threat to public safety from the carousel of delivery drivers and customers using this entrance and adjacent pavements as parking spaces, and if we're speculating, maybe even the odd "comfort stop"?
- Apparent observations of antisocial behaviour being directly attributable to patrons of the
  Taproom are circumstantial, speculative and offensive. Quite simply, no-one needs to walk from
  the Taproom to the entrance of Bishops Courtyard to relive themselves, smoke or whatever else
  antisocial behaviour the residents claim. The bathroom facilities are more than appropriate for
  the size of the Taproom and there are seats and tables for any smokers directly outside.

Of the four licencing objectives to be met, those objecting only seem to be focused on one, using deliberately emotive language and speculation to suggest that public nuisance will increase.

My support for allowing the Taproom to stay open during the same hours as any other public house in the city is my support for a small, independent business continuing to be a thriving, well-supported and well-regarded concern.

I write in support of the above application to extend the opening hours of the Little Monster Tap.

It is well recognised that the LMT has become over the years a community and cultural hub in Chichester, employing local people and showcasing local produce. Additionally, as an independent business, it brings variety and texture to the overall experience of visitors to the city, and the extension of opening hours can only enhance this experience.

I understand that objections to this extension have been raised regarding;

1/the prevention of crime and disorder,

2/ public safety,

3/the prevention of public nuisance

4/ the protection of children from harm.

Of course, these are all matters that should concern the residents of Chichester and all of civil society.

Regarding the prevention of crime and disorder, I should point out that in the 5 years I have been coming to the Hornet Alehouse, and latterly the Little Monster Tap, the police have never been called upon because of anti-social behaviour of any nature. Nor have any local residents hitherto voiced concern over such behaviours.

I fail to see how the extension of opening hours might cause any alarm to local residents on these grounds, or indeed on grounds of public safety, given that there is no history of any such behaviour.

Certain complainants have alleged that the courtyard area in front of their properties has been used for the purpose of public urination and defecation. Again, in all the time I have been a patron of the above establishments, never have I heard this concern raised to the management, or to customers.

I concede the such anti-social behaviour may occur in that area, but to allege that this is due to the customers of the LMT is specious and without foundation. Certainly, no evidence to the contrary has been forthcoming.

I am at a loss as to why the protection of children should be an issue here at all.

The Hornet and The Little Monster Tap have always been safe, inclusive and welcoming places. How children might be put at any risk by the extension of opening hours is beyond me.

In short, I would ask the licensing committee to grant the proposed extension of the current license, and to dismiss these objections as groundless.

I am writing in support of the above application from The Little Monster Tap (LMT) and its request to extend its opening hours by 90 minutes in the evening.

Tap rooms and Micropubs have been pivotal in breathing life into high streets up and down the country by repurposing unused retail units which is part of their attraction and uniqueness in the eyes of the customers who frequent them.

Since the opening of the Hornet Ale House, and it's subsequent change into the Little Monster Tap Room, I would be highly surprised if there was any recording reporting of Public Nuisance or disorder as a result of patrons from the pub and for there to be any suggestion that this would start occurring due to the introduction of an additional 90 minutes of trading is an outlandish suggestion - especially considering that a Public House 50 metres away trades until 11pm five nights a week and until 12am on Fridays and Saturdays.

Whilst I can understand some of the objections from residents situated behind the Tap Room I do get the feeling that their arguments are lazy and disingenuous; to suggest that additional noise generated from "bottling up" or "additional waste" when the products served by the Tap Room are a 95% mix of draft ale and cans is really showing a lack of understanding of the trade of the Micropub.

Furthermore, any argument based on a Micropubs number of toilets and the requirement to queue to use it is farcical at best. There are three Micropubs in Chichester, all of which have one toilet - I have been to sporting and musical events in large venues with multiple toilet facilities and still had to queue up to use them.

For an objection argument to suggest that if a business needs the 90 minute's additional to remain trading they should move location to a livelier part of Town shows a complete misunderstanding of how thriving sub districts are created in forward thing and progressive Towns, variety is key and the focus on small, independent and alternative offerings is what brings a unique feel to the Hornet/Drapers yard area which is unlike any other part of Chichester.

Any suggestion that the entrance of the courtyard is being used by patrons of the Tap Room to congregate to smoke and/or urinate are completely irrational considering the number of customers/delivery drivers using that drop off point to use the Take Aways adjacent to it.



I am writing in support of the above application.

Firstly, I have been a regular customer of both The Hornet Alehouse since its inception in 2018 and of its successor, The Little Monster Tap, since that business began operations earlier this year and thus believe that I am in a reasonable position to assess and address the various objections to the licensing extensions which have recently been put forward.

I will respond specifically to those comments raised by Mr Simon Ratcliffe in his letter dated 14<sup>th</sup> July, as this appears to be the most comprehensive in terms of its objections.

Firstly, the complainant alleges that "we have seen the level of noise, cigarette butts and general congregation of vapers, smokers and general bon homie (sic) outside of the premises and the entrance to our courtyard increase in the last few months". I can state categorically that this is not the case, with the possible exception of bonhomie (noun: cheerful friendliness; geniality) which, I would concur, continues to be the case and which I would feel is generally what one looks for in a licensed establishment.

It is unfortunate that on his visit to the property, the complainant had to queue behind three individuals prior to gaining access to the lavatory. Clearly this is an experience which the objector has not encountered in his past experience when using the facilities at any pubs, restaurants, clubs and indeed public conveniences, and hence his sense of indignation on this occasion. I would tentatively suggest that, firstly, if this is indeed an isolated experience in the individual's life, he has been more fortunate than most of his peers; secondly, that during my own (many) visits to the establishment, I have never had to wait more than a couple of minutes to use said facilities, a period of time I think that most of us would not consider excessive.

The complainant then alleges that as a result of this supposed excess queuing time, some patrons "enter through our gates and urinate against the wall and dustbin area". I find this highly improbable (given that the patrons are content to queue – see above) and would suggest that if individuals are indeed urinating in the courtyard, then they might well be patrons of other establishments, regrettably using the courtyard for a "comfort break" on their walk home.

The rest of the objection is littered with a plethora of hypotheticals and conditionals, none of which is backed up with evidence to suggest that these scenarios either (a) have a significant probability of playing out or (b) represent a risk to the community, the patrons or indeed the author of the objection.

Let us take a couple of these choice morsels as exemplars:

- "The increased trading hours will generate more waste and whist presently the bins seem to be accessed the next day it is possible that these increased hours may require the management to dispose of bottles cans and ancillary rubbish during trading hours which will affect us late at night." In modern parlance, "it is possible" could be said to be performing an awful lot of "heavy lifting" in this case. Will they dispose of said items during trading hours? And, if they did, would it really have an adverse impact upon the complainant?
- "We believe that the extended hours may make the departing staff vulnerable there is rarely more than one in attendance." Why? Where is the evidence for this? What is the likelihood of this? Has it happened under current opening hours and what is the level of increased risk?

The complainant argues that four licensing objectives (Public safety, prevention of crime and disorder, prevention of public nuisance and the protection of children from harm) "will not be met with the revised hours". At no point in his objection does he provide any reasonable rationale why there would be any risk posed to any of these. Public safety? A claim that there are "exiting issues from the establishment in the case of fire". Are there? Are there really? And are these any greater after 9.30pm? Prevention of crime and disorder? Where is the evidence to suggest that marginally increasing the licensing hours of a micropub patronized primarily by real ale enthusiasts will result, directly or indirectly in crime and/or disorder? The same goes for prevention of public nuisance. And as for the protection of children from harm, I am perplexed as to why the complainant even brings this to the table (the body of the letter fails to produce one single argument as to why this licensing objective might not be met).

Both the Hornet Alehouse and its successor, the Little Monster Tap, have been a credit to the community: more than that, they have created a sense of community, successively attracting a host of

Add to this that the general demographic that attend LMT prefer quality over quantity, as such are not out to get drunk, and therefore statistically the probability of crime, disorder and public nuisance from an LMT patron is significantly less - whilst not zero , I do not believe there have been any incidences linked to LMT to date.

I have seen the comments regarding the toilets and whilst at times during events a queue can form, the turnaround is normally quite quick, and I've never had to wait more than a few minutes before using the facilities.

Public safety.

The Little Monster Tap is a safe place for all, irrespective of gender, ability, or sexuality. The staff go all out to make all feel welcome. I have witnessed an off-duty staff member actually rush out into the street to provide assistance and first aid to a member of the public who had been walking along the hornet and had tripped and fallen.

As a customer of this establishment I was surprised to read the objections that have been raised around rowdy and anti-social behaviour. In over five years I have never witnessed any such behaviour and find it hard to believe that the decent and considerate people I have mixed with at the Little Monster Tap would act in this way. It would also seem that the alleged public order offences we are told take place in the bin area to the rear of the premises (which cannot with any credibility be attributed to LMT customers) could be entirely negated with a small adjustment to the courtyard gates to enable them to be locked from the outside but safely opened from within the courtyard.



      - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
    - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
    - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 4 (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

Signed:

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 5 The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
  - 2. For the purposes of the condition set out in paragraph 1-
    - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
    - (b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
  - (i) the holder of the premises licence,
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that

sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 2 – Conditions consistent with the operating schedule

- A "Challenge 25" policy whereby any person attempting to buy alcohol who appears to be under 25 will be asked for photographic identification to prove their age. The recommended forms of identification that will be accepted are passports, driving licences with a photograph, photographic military ID or proof of age cards bearing the 'PASS' mark hologram.
- 2 Suitable and sufficient signage advertising the "Challenge 25" policy will be displayed in prominent locations in the premises.
- The Premises Licence Holder shall ensure that all staff members, engaged or to be engaged, in selling alcohol at the premises shall receive the following induction training. This training will take place prior to the selling of such products:
  - The lawful selling of age restricted products
  - Refusing the sale of alcohol to a person who is drunk

Further verbal reinforcement/refresher training covering the above will be carried out thereafter at intervals not to exceed eight (8) weeks, with the date and time of the verbal reinforcement/refresher training documented.

All such training undertaken by staff members shall be documented and recorded. All training records shall be made available to officers of any Responsible Authority.

- Digital CCTV and appropriate recording equipment to be installed in accordance with Home Office Guidelines relating to UK Police Requirements for Digital CCTV System (PSDB Publication Number 09/05), operated and maintained throughout the premises internally and externally to cover all public areas and within the booth areas, including the entrance to the premises. The system shall be on and recording at all times the premises licence is in operation.
  - The CCTV cameras and recording equipment must be of sufficient quality to work in all lighting levels inside the premises at all times.
  - CCTV footage will be stored for a minimum of thirty one (31) days.
  - The management will give full and immediate cooperation and technical assistance to the police in the event that CCTV footage is required for the prevention and detection of suspected or alleged crime. A member of staff must be present at all times who can operate the system and supply copies of these images on request to either police, council or other authorised officer.
  - The CCTV images will record and display dates and times, and these times will be checked regularly to ensure their accuracy.
  - Subject to Data Protection guidance and legislation, the management of the premises will ensure that key staff are fully trained in the operation of the CCTV, and

- will be able to download selected footage onto a disk for the police without difficulty or delay and without charge to Sussex Police.
- Any breakdown or system failure will be notified to the police immediately and remedied as soon as practicable.
- In the event of the CCTV system hard drive being seized as evidence as part of a criminal investigation by Sussex Police or for any other reason, the premises will be expected to install a replacement hard drive or a temporary replacement drive as soon as practicable.
- An incident log will be maintained at the premises showing a detailed note of incidents that occur in the premises and any refusal of alcohol. The incident log will be inspected and signed off by the Designated Premises Supervisor (or a person with delegated authority) at least once a week. An incident will be defined as being one which involves an allegation of a criminal offence. Any refusals made at any of the bars/point of alcohol service e.g.: for intoxication, will also be recorded in writing.
- Off sales will be limited to cask beer and cider in sealed containers, or beer in bottles or cans.
- 7 No tapped lagers, or spirits, will be sold for either on or off sales.
- Patrons will not be permitted to take drinks outside in open containers beyond the licensed perimeter of the premises to consume whilst smoking or congregating outside.
- Persons under the age of 18 years are only permitted to be on the premises until 1800hrs and must be accompanied by an adult.
- The Premises Licence Holder and/or members of staff will monitor the departure of customers to ensure they do so in a quiet and orderly manner as to not cause a disturbance to others.
- 11 Contact details for taxi companies along with bus/train information will be available to customers.






