

Chichester Sustainable Transport Corridors Stage 2 Consultation Survey

We're working to improve sustainable transport facilities and would like to understand your views on our proposals for A286 Oaklands Way between the Northgate Gyratory and College Lane, and A285, Chichester to Tangmere, between St. Pancras, Chichester and A27 at Tangmere.

As well as helping to improve the health, wellbeing and safety of West Sussex residents, it is hoped that improving routes for sustainable transport, will support the local economy, reduce pollution, benefit users who do not have access to a car, and tackle climate change. This will also help achieve national targets for cycling and walking to be the natural first choice for many journeys with half of all journeys in towns and cities being cycled or walked by 2030.

A summary of the proposals for the schemes is provided below:

A286 Oaklands Way, from Northgate Gyratory in the west to College Lane in the east (Option 1 – Shared-use)

- Exiting from the Northgate Gyratory the existing cycle lane would divert into a new 3m wide shared-use two-way footway/cycle lane, on the northern side of Oaklands Way.
- The width of the shared-use facility would range between 3m and 5.1m, excluding the existing verge.
- The majority of the length of the proposals is shared-use width 3.5m.
- Mature trees to be retained at the western end of Oaklands Way restrict available width to 3m.
- The existing bus-layby to be relocated to accommodate the new walking and cycling facility and it would be replaced with an on-road bus stop, in a similar location to the existing bus layby.
- Raised table shared cyclist and pedestrian crossing at Festival Theatre Car Park entrance to reinforce the priority of walkers and cyclists.
- Uncontrolled pedestrian crossing points would be installed at New Park Road roundabout.
- The scheme would provide connections to existing and new facilities at the western and eastern ends of the route to facilitate onward trips. This would include a new Toucan crossing (which would be delivered separately from these proposals) to allow a safe crossing point into Franklin Place and North Street.
- Access via the existing underpass at Northgate Gyratory would be retained.



A286 Oaklands Way, from Northgate Gyratory in the west to College Lane in the east (Option 2 – Segregated)

- As option 1 above, but this option would provide a segregated two-way 3m cycle track alongside a 2m footway with 0.5m separation starting approximately 100m after the exit from Northgate Gyratory through to College Lane.
- This option would involve removing the existing verge in some places or maintaining a small 0.5m verge where space allows.
- The western end of proposal from Northgate Gyratory would start as shared-use facility, due to mature trees to be retained reducing available width.
- It is believed that this segregated option can be accommodated without the need to reduce eastbound traffic lanes along Oaklands Way, however more detailed survey of the space available is required at the next design stage to confirm this.

A285 Westhampnett Road, Chichester to Tangmere, from St. Pancras in the west to A27 at Tangmere in the east.

- This option would provide a 3m wide two-way segregated cycle track alongside a 2m footway on the southern side of A27 from Tangmere in the east to a point approx. 50m east of the A27 Portfield roundabout, where reduced width restricts the level of provision that can be provided. Section of third-party land would be required between Tangmere and Coach Road to keep the facility away from the A27.
- Two options are proposed for a small section by Westbourne House Lakes. This would either be a wooden bridge over the drainage pond, or a segregated cycle track south of the drainage pond. This is an alternative option to avoid taking the proposals closer to third party land.
- A pedestrian/ cycle bridge (recently constructed, now open) has been provided over the A27 Westhampnett Bypass to connect the Shopwyke Lakes development with an existing footway on the northern section of Coach Road, to the watersports centre.
- The scheme would also connect to B2144 Oving Road to the west of Portfield roundabout and link to Public Right of Way 553 via a new bridge structure (yet to be constructed).
- A new shared-use footway/cycleway along the western side of A285 Portfield Way linking to the existing Public Right of Way 553 through Portfield retail park and connecting to Church Road. This would require a small section of third-party land subject to being secured.
- Subject to agreement from landowners, the existing footpath alongside the former football ground could be widened and designated as a shared-use footway/cycleway.
- This would connect to a recently upgraded 3m footway running alongside St James Industrial Estate, linking to Westhampnett Road



- The existing pelican crossing to the east of St. James Industrial estate would be maintained.
- A proposed segregated two-way 3.5m cycle track and 2.1m footway on the southern side of Westhampnett Road until the junction with St. James Road, where it then changes to a shared-use path to Spitalfield Lane.
- The St. James Road junction would be converted from an existing mini roundabout to a signal-controlled junction with toucan crossings. This would be complimented by traffic signal priority technology, which would improve the reliability of bus journey times.
- The right turn lane into St. James Industrial estate would be removed and carriageway width reduced to 6m to accommodate the two-way segregated cycle track/footway.
- A segregated two-way 2m cycle track and 1.8m footway facility would continue for a short distance from west of Spitalfield Lane on southern side of Westhampnett Road to the existing pelican crossing linking to Bridge Road.
- A short section of shared-use footway/cycleway is then proposed between the existing pelican crossing and Tozer Way.
- Segregated two-way 2.4m cycle track and 2.0m footway facility from Tozer Way to St. Pancras, switching to the north side of St Pancras at Needlemakers.
- To incorporate a two-way segregated cycle track and footway on the eastbound one-way A286 St. Pancras section the carriageway will need to be reduced down to a single lane.
- All side roads would have raised table entry treatments to encourage lower vehicle speeds and prioritise pedestrian and cyclist movements.
- The removal of some parking may be needed on the southern side of the A285 Westhampnett Road, between the A286 Needlemakers and Spiltalfield Lane junction. Parking on the northern side of the carriageway would remain unchanged.
