

# **Chichester District Council Schedule** of Executive Decisions by Officers

The Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 require that as soon as reasonably practicable after an officer has made a decision which is an executive decision the officer must produce a written statement which must include—

- (a) a record of the decision including the date it was made;
- (b) a record of the reasons for the decision;
- (c) details of any alternative options considered and rejected by the officer when making the decision;
- (d) a record of any conflict of interest declared by any executive member who is consulted by the officer which relates to the decision; and
- (e) in respect of any declared conflict of interest, a note of dispensation granted by the relevant local authority's head of paid service.

Government guidance makes it clear that the requirement to record decisions extends only to 'executive decisions'. 'Decisions which are taken by officers under specific delegations from a meeting of their council's executive are clearly executive decisions. However, many administrative and operational decisions officers take on how they go about their day to day work will be delegated within the council's rules and are not in this 'executive decisions' category; as such they do not need to be recorded.'

This schedule, therefore, records executive decisions made by officers under specific delegation from the Cabinet. This usually happens when the Cabinet takes a decision in principle but authorises an officer, sometimes in conjunction with a Cabinet member, to make a detailed decision.

The schedule must be kept updated by officers when they make executive decisions and Democratic Services will upload the updated Schedule to Chichester District Council's (CDC) website periodically.
