2 Additional Third Party Objections

Since this application the Chichester Conservation Area has been extended to include Oving Road between The Hornet and the Florence Road Junction.

Closing the Oving Road traffic lights in accordance with the conditions of planning permission 11/05283 would be consistent with the requirement to preserve or enhance the character or appearance of the area.

Conversely, to permit this application would be tantamount to allowing further destruction of the character and appearance of the area.

The junction is not fit for purpose for the volume of traffic using this road which has increased substantially in recent years. Congestion at these traffic lights makes it impossible for the close proximity residents to access or leave their property when the lights are red. When the lights are green we live in fear of safety as vehicles travel well in excess of the speed limit. That is of great concern as there is no pavement on our side of the road. The road is no longer fit for purpose and is causing damage to our houses also with movement.
