Other members – 9 members appointed by the Cabinet on the recommendation of the Cabinet Member for Housing, Communications, Licensing and Events

**Frequency:** Quarterly

### **Broad Objectives:**

To advise the Cabinet on policy relating to the Housing Strategy

To advise the Cabinet on all Housing related policies including (but not limited to):

- Housing standards & Financial Assistance
- Enforcement policies
- Allocations policy

To identify priority policy areas for working with partners to reduce rough sleeping

To advise on policy for delivery of affordable housing in the district.

To advise the Cabinet on Communities related policies including (but not limited to):

- Anti-social behaviour policy
- Safeguarding Policy

To advise on policy relating to Wellbeing and Social Prescribing services, the Community Safety Partnership, Community Engagement and other services delivered with the Communities team.

To advise the Cabinet on policies relating to Revenues & Benefits, and Customer Services.
