## CHICHESTER DISTRICT COUNCIL FORWARD PLAN FOR THE PERIOD 1 JULY 2015 TO 31 OCTOBER 2015

This Forward Plan outlines the decisions which are expected to be made by the Council's Cabinet during the period of four months from 1 July 2015 to 31 October 2015. On occasions the timetable for reports may change due to unforeseen circumstances. Additionally the Forward Plan also identifies decisions which are likely to be taken by the Cabinet in the coming year beyond the four month period covered by the Plan.

The meetings of the Cabinet due to be held during this period are, 7 July 2015, 8 September 2015 and 6 October 2015 to be held at the offices of Chichester District Council, East Pallant House, East Pallant, Chichester.
