The proposed building would be of a greater length than the width of the dwelling that it would serve and combined with its height would compete visually with Estoril lacking subservience to it. ... However the proposed garage by virtue of its overall scale and design in such a prominent location would appear incongruent within to preserve the character and appearance of the Conservation Area..."
