Appeal Decision: APPEAL ALLOWED

"The appeal is allowed and planning permission is granted for erection of hard standing area to allow vehicular access to the site. The proposed grasscrete hard standing would cover the area of existing aggregate and extend to the front of the field gate across the grass verge to meet the carriageway to enable a vehicle to enter the site. Whilst the proposal would involve clearance of some overgrown grassed areas and cutting back of shrubs, this does not equate to habitat loss. The proposed use of grasscrete as a material for the hardstanding would enable grass and other vegetation to grow within the voids of the hardstanding's structure. Therefore, whilst the hardstanding would initially have an engineered appearance, this would be enable grass and other vegetation to grow within the voids of the hardstanding's structure thereby minimising its visual impact. ... The proposal would not have an adverse impact on the verdant, rural character of the surrounding landscape. The proposal would not therefore harm the character and appearance of the area, with particular regard to the landscape and scenic beauty of the South Downs National Park. ..."
